## PROFESSIONAL REGULATION COMMISSION

Resolution No. 925 Series of 2015

RESCHEDULING THE AUGUST 2015 BOARD LICENSURE EXAMINATIONS FOR GEODETIC ENGINEERS FROM AUGUST 18-19, 2015 TO OCTOBER 13-14, 2015, AMENDING FOR THE PURPOSE PRC RESOLUTION NO. 2014-874 AND RESOLUTION NO. 2014-880 (A)

WHEREAS, the Professional Regulation Commission is vested with the power to administer and conduct the licensure examination of the various regulatory boards in accordance with the rules and regulations it may prescribe and <u>to determine and fix</u> the places and dates of examination, xxxxx;

WHEREAS, in the exercise of this mandate, the Commission issued Resolution No. 2014-874 and Resolution No. 2014-880 (A) fixing the dates and venues of the professional licensure examinations for calendar year 2015, with the Board Licensure Examination for Geodetic Engineers (BLEGE) scheduled on August 18-19, 2015 in the City of Manila;

WHEREAS, there are universities/colleges which have shifted to a new academic calendar and whose students will graduate in the month of June of this year;

**WHEREAS**, there are appeals to reschedule the August 2015 BLEGE to enable students whose graduation will fall on June 2015 to take said licensure examination;

WHEREAS, the deans of different colleges offering the Bachelor's Degree in Geodetic Engineering have likewise requested for the rescheduling of the BLEGE this year to facilitate the issuance of the Transcript of Records (TORs) to their graduates;

**WHEREAS**, the Professional Regulatory Board of Geodetic Engineering (Board) has favorably considered and endorsed the approval of said requests, after consultation with the academe and other stakeholders;

**NOW THEREFORE**, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to amend Resolution Nos. 2014-874 and 2014-880 (A) by rescheduling the BLEGE to October 13-14, 2015;

**FURTHER RESOLVED**, that the deadline for the filing of applications for the October 2015 BLEGE be set on September 23, 2015.

Let copies of this Resolution be posted in PRC official website and furnished the Board, Office of the Director for Licensure, Application Division, Examination Division, Rating Division, ESTF, ICT Division, Secretariat, Supply & Property Division, Budget Division, Accounting Division, Legal Division and all PRC Regional Offices for information and guidance.
