RESCHEDULING OF THE MAY 8, 9, 15, AND 16, 2016 BOARD LICENSURE EXAMINATION FOR CERTIFIED PUBLIC ACCOUNTANTS (BLECPA), AMENDING FOR THE PURPOSE PRC RESOLUTION NO. 948, SERIES OF 2015, ON THE SCHEDULE OF THE LICENSURE EXAMINATIONS FOR YEAR 2016

WHEREAS, Section 7 (d) of Republic Act No. 8981, otherwise known as the PRC Modernization Act of 2000, grants to the Professional Regulation Commission (Commission) the power and duty to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to **determine and fix the places and dates of examinations**;

WHEREAS, the Commission issued PRC Resolution No. 948, Series of 2015, providing for the schedule of the licensure examinations, practical examinations, professional upgrading examinations, Special Professional Licensure Board Examinations (SPLBE) for calendar year 2016, as well as the deadlines for the filing of applications therefor, and the target dates of the release of the examination results;

WHEREAS, the schedule of the BLECPA is on May 8, 9, 15 and 16, 2016 per the aforementioned PRC Resolution;

WHEREAS, the national elections next year will fall on May 9, 2016;

WHEREAS, in order not to disenfranchise the examinees from exercising their right to suffrage, the Board has recommended for the resetting of the BLECPA to May 11, 12, 15 and 16, 2016;

WHEREFORE, upon due consideration, the Commission has **RESOLVED**, as it so **RESOLVES**, to amend PRC Resolution No. 948, Series of 2015, by rescheduling the May 8, 9, 15 and 16, 2016 BLECPA to May 11, 12, 15 and 16, 2016;

This Resolution shall take effect immediately upon its full publication in any newspaper of general circulation in the country.

Let copies of the same be posted at the PRC official website and further distributed to the Board, Office of the Board Secretary, Licensure Office, Examination Division, Rating Division, all Regional Offices of the Commission and the Commission on Higher Education (CHED) for wider dissemination.
