**PHYSICAL AND OCCUPATIONAL THERAPIST LICENSURE EXAMINATIONS
RESULTS RELEASED IN THREE (3) WORKING DAYS**

The Professional Regulation Commission (PRC) announces that **370** out of **711** passed the Physical Therapist Licensure Examination and **25** out of **88** passed the Occupational Therapist Licensure Examination given by the **Board of Physical and Occupational Therapy** in the cities of **Manila** and **Cebu** this **February 2014**.

The members of the Board of Physical and Occupational Therapy who gave the licensure examinations are **Pollyana G. Escano**, Chairman; **Raul G. Agustin**, **Bernadette M. Reyes**, **Delia R. Pabalan** and **Rolland Lyle D. Duque**, Members.

The results were released in three (3) working days from the last day of examinations.

Registration for the issuance of Professional Identification Card (ID) and Certificate of Registration will be on February 13 & 14, 2014. Those who will register are required to bring the following: duly accomplished Oath Form or Panunumpa ng Propesyonal, current Community Tax Certificate (cedula), 1 piece passport size picture (colored with white background and complete name tag), 2 sets of metered documentary stamps and 1 short brown envelope with name and profession and to pay the Initial Registration Fee of ₱600 and Annual Registration Fee of ₱450 for 2014-2017. **Successful examinees should personally register and sign in the Roster of Registered Professionals.**

The date and venue for the oath-taking ceremony of the new successful examinees in the said examination **WILL BE ANNOUNCED LATER.**
