Resolution No. 03 Series of 2013



RESOLUTION PRESCRIBING THE PERCENTAGE WEIGHTS FOR THE SUBJECTS IN THE BOARD LICENSURE EXAMINATION FOR INTERIOR DESIGNERS (BLEID)

WHEREAS, Section 16 of Republic Act No. 10350, known as the Philippine Interior Design Act of 2012 and Section 18 of Resolution No. 02, Series of 2013 or the Implementing Rules and Regulations of R.A. No. 10350 provide for the subjects that will be covered in the Board Licensure Examination for Interior Designers (BLEID);

WHEREAS, R.A. No. 10350 included the subject Color Theory in the scope and coverage of the Board Licensure Examination for Interior Designers (BLEID);

WHEREAS, the rationale for prescribing the percentage weight for each of the licensure examination subject is to underscore which examination subjects are of major or minor relevance or importance in the actual practice of a given profession;

WHEREAS, this apportionment of percentage weights is intended to gauge more effectively the individual examinee's proficiency in the various component subjects of the licensure examination:

WHEREAS, the Board deemed it appropriate to make the necessary adjustments in the percentage weights previously assigned to the subjects covered in the Board Licensure Examination for Interior Designers (BLEID);

WHEREAS, after consultation and deliberation with the members of the academe, Council of Interior Design Educators (CIDE) and Philippine Institute of Interior Designers (PIID), the Board made a determination of the percentage weight that will correspond to each of the subject in said licensure examination;

NOW THEREFORE, the Board RESOLVES, as it is hereby RESOLVED, to prescribe and adopt the percentage weights for the following subjects in the Board Licensure Examinations for Interior Designers (BLEID), viz;

Subjects	Percentage Weight
Interior Design	40%
Furniture Design and Construction	15%
Materials of Design and Decoration	n 10%
History of Arts and Interior Design	10%
Interior Construction and Utilities	10%
Color Theory	5%
Professional Practice and Ethics	10%
	100%



FURTHER RESOLVED, that this Resolution be implemented for the October 1, 2 and 3, 2013 and every subsequent Board Licensure Examination for Interior Designers (BLEID).

This Resolution shall take effect fifteen (15) days following its full and complete publication in the Official Gazette or any newspaper of general circulation in the Philippines.

Let a copy hereof be furnished the PRC Rating Division, Examination Division, Records Division, Office of the Professional Regulatory Board Secretariat, the academe, the accredited and integrated professional organization of the interior designers and other concerned parties.
