RESOLUTION NO. __08 ___ Series of 2013

RESCHEDULING THE OCTOBER 2013 ELECTRONICS ENGINEERING LICENSURE EXAMINATION TO DECEMBER 13, 14 AND 15, 2013 IN THE CITIES OF MANILA, BAGUIO, CEBU, DAVAO, ILOILO AND LUCENA

WHEREAS, Section 13, Article III of Republic Act No. 9292, known as the "Electronics Engineering Law of 2004" provides that the Licensure Examinations for Electronics Engineers and Electronics Technicians shall be given by the Board in such places and time as the PRC may designate;

WHEREAS, under Commission Resolution No. 2012-689 dated November 12, 2012, the Licensure Examinations for Electronics Engineers and Electronics Technicians were scheduled on April 14, 15 and 16, 2013 and on October 18, 19 and 20, 2013;

WHEREAS, due to the vacancies in the Board, the Commission issued Resolution No. 2013-773 on July 23, 2013 for the postponement of the October 2013 licensure examination for Electronics Engineers and Technicians until the new members of the Board are appointed and qualified;

WHEREAS, the new chairman and members of the Board of Electronics Engineering have been appointed and sworn to office on September 5, 2013;

WHEREAS, the new members of the Board of Electronics Engineering after having been sworn to office, have in consideration, during their first Board Meeting on September 5, 2013, the rescheduling of the Electronics Licensure Examination from October 2013 to December 13, 14 and 15, 2013 in the cities of Manila, Baguio, Cebu, Davao, Iloilo and Lucena;

WHEREAS, above schedule of licensure examination for Electronics Engineers and Electronics Technicians shall give enough time for the newly appointed professional regulatory boards to prepare valid test questions in their respective subjects and also reasonable time for the processing of applications and other examination related activities of the Commission;

NOW, THEREFORE, the Board RESOLVES as it is hereby RESOLVED, to recommend to the Commission the rescheduling of the October 2013 Licensure Examinations for Electronics Engineers and Electronics Technicians to December 13, 14, and 15, 2013 in the cities of Manila, Baguio, Cebu, Davao, Iloilo and Lucena.

FURTHER RESOLVED, that this Resolution shall take effect fifteen (15) days following its full and complete publication in a newspaper of general circulation.

Let copies of this Resolution be furnished the Professional Regulatory Board of Electronics Engineering, Office of the Secretary to the Professional Regulatory Boards, Licensure Office, Application Division, Examination Division, Rating Division, ESTF, ICT Division, Legal and Investigation Division, Supply and Property Division, Accounting Division, Budget and Management Division and all PRC Regional Offices for information and proper dissemination.
