- 1. Applicants shall first verify their names from the LIST OF CONDITIONALLY-APPROVED APPLICANTS at the Philippine Embassy/Consulate/POLO.
- 2. Applicants shall proceed to the authorized Overseas Remittance Office (ORO) of the Land Bank of the Philippines (LBP) listed below to remit the examination fee.

- 6. The Notice of Admission (NOA) and Official Receipt will be issued to the applicants as proof of admission by the PRC Team on the registration day.
- 7. FAILURE TO REMIT THE EXAMINATION FEES ON OR BEFORE REGISTRATION PERIOD WILL MEAN NON- ADMISSION IN THE EXAMINATIONS.
